In consideration of my child's participation, I hereby release and covenant not-to-sue **Infamous Athletics** and/or any of its employees, teachers, coaches, or agents, from any and all present and future claims resulting from ordinary negligence on the part of **Infamous Athletics** or others listed for property damage, personal injury, or wrongful death, arising as a result of my child's engaging in or receiving instruction in gymnastics, cheerleading, or any other activities or any activities incidental thereto, wherever, whenever, however they may occur. I hereby voluntarily waive any and all claim resulting from ordinary negligence, both future and past, that may be made by me, my family, estate, heirs or assigns.

Further, I am aware that gymnastics and cheerleading are vigorous sporting activities involving height and rotation in a unique environment, and as such, they pose a risk of injury. I understand that gymnastics and cheerleading and related activities always involve certain risk, including but not limited to, death, serious neck and spinal injuries, resulting in complete or partial paralysis, brain damage, and serious injury to virtually all bones, joints, muscles, and internal organs, and that mats, pits, and other safety equipment and apparatus provided for my protection, including active participation or a coach or teacher who will spot or assist in the performance of certain skills, may be inadequate to prevent serious injury. The risk of harm may be limited by all of the safety equipment and trained coaches, but never eliminated. I understand that participation in gymnastics, including moving from event to event, conditioning, stretching and other activities which may leave me vulnerable to the reckless actions of other participants who may not have complete control over their actions or who may not see other students in the gym. I am voluntarily allowing my child to participate in this activity with knowledge of the risks involved and hereby agree to accept any and all inherent risks of property damage, personal injury, or death.

I further agree to indemnify and hold harmless **Infamous Athletics** and all others listed for any and all claims arising as a result of my child's engaging in or receiving instruction in activities incidental thereto, whenever, wherever, or however the same may occur. If an injury occurs, the party hereby contracts and agrees that their individual medical coverage is deemed primary in any and all situations.

I give permission to **Infamous Athletics** and its officers and staff to provide medical treatment in case of an emergency or injury.

I further authorize **Infamous Athletics** the irrevocable right to use photographs of my child and myself in all forms, media and manners, without restriction for advertising, promotion, or any other lawful purposes.

I understand that this waiver is intended to be as broad and as inclusive as permitted by the laws of the state of Louisiana and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further agree that the venue for any legal proceedings shall be within the state of Louisiana.

I affirm that I am of legal age and am freely signing this agreement. I have read this form and fully understand that by signing this form, I am giving up legal rights and or remedies which may be available to me for the ordinary negligence of **Infamous Athletics** or any person/entity listed above.
